READY FOR PLANTING

Happy Father's Day. Hopefully, summer will be gentle to us with fewer 90+ degree days than last year. As reflected in the April 30, 2017 Income/Expense Statement, the Village's year to date finances remain on track. Miscellaneous Income is over for the month primarily due to an April accounting correction of \$4,800 for an incorrect write off done in August 2016 plus various unbudgeted income sources. Professional Fees were under budget this month due to our attorney's quarterly billing methodology. Clubhouse Expense is over \$3,021 for the month due to the repair of the asphalt walkway along Congasia Road. The Other Expense category is over for the month due to two one-time expenditures: \$3,313 for Carriage Shed common ground core aeration/seeding and \$3,255 for a Carriage Shed driveway repair and re-paving. The other item in this category is street lighting, which amounted to \$2,155.64. We are still waiting to receive the \$11,100 in FEMA storm damage money.

Solar production is going well. EZenergy began selling our SRECs (Solar Renewable Energy Certificates) which we are using to repay our Solar Installation reserve loan. In April, a total of 19 SRECs were sold @ \$223.50 each for \$4,246.50. In May, another 9 SRECs were sold @ \$211 for a total of \$1,899. So far along with our solar referrals, we have repaid \$8,187 towards our solar project cost of \$228,977.

By the time you read this, the Election Procedural and Voting Procedure Committee hopefully will have finalized their efforts for the BOT. Ron Paluzzi and I wish to thank Valerie O'Neill, Carol Bonacci, Sharron Brauer, Warren Ciafardini, Nancy Hoffman, Bill Kozuszko, Gren Pasquarella, Michele Reina, Julie Sutton and Paul Wannemacher for their many hours of volunteering their time towards developing the enclosed Election Procedures.

How large is Crestwood Village Six?

How large is Crestwood Village Six is a question many residents do not know the answer to be a new resident or one who has been here for decades.

Crestwood Village Six is a property of approximately 277.5 acres in size. The housing units in the village consist of 490 Single buildings, 169 Double units (duplexes) buildings, 24 Tri Plex, 59 Quad and 1 Five Plex unit totaling 743 actual building with 1141 housing units.

Unfortunately, we cannot give you a population count or even a male to female ratio as many of our residents have not turned in the HOPA form that is required by law to be filled out every year. PLEASE FILL THEM OUT AND RETURN TO THE OFFICE. Crestwood Village Six Association Inc. is a non-profit association.

Limited use of Decorative Stone

Article VI Section 5 of the Declaration of Covenants and Restrictions states the following:
"To maintain the county and park like setting of the community, lawn areas surrounding house units must remain grass areas. It is prohibited for lawns to be replaced by crushed stone, decorative stones, bricks or any other ground covering. The limited use of stone or other mulch covering is only allowed in approved planting beds set forth in the planting guide."

JUNE RESOLUTIONS

Funds # 17-05

RESOLVED: The Board of Trustees of Crestwood Village Six Community Association resolve that now and in the future any and all excess budgeted operating expense for After Hours Snow Removal/Salt may be expensed at the discretion of the presiding Board of Trustees in the appropriate fiscal year and set aside as a Snow Removal Reserve Fund.

Explanation – This proposed resolution would allow the Board of Trustees to set up a Reserve Fund account for Snow Removal. The possible use of this fund is when excessive winter storms cause the annual operating budget amount for snow removal to be exhausted. This fund could be added to each year and hopefully avoid the need for possible special assessments for snow removal in the future. Discussion on this resolution will take place at the Open Trustees meeting on June 7th. Account #6095 for After Hours Snow Removal/Salt is currently under budget by \$10,188.65.

If after said discussion is heard and if the Board of Trustees passes this resolution, \$10,000 will be expensed in June 2017 to Account #6095 and a special Snow Removal Reserve Account will be created in our Edward Jones Replacement Funds account in the amount of \$10,000.

Procedure #17-06

RESOLVED: The Board of Trustees of Crestwood Village Six Community Association propose the attached revision of our Village Trustee Election Procedures.

Explanation – This proposed resolution is the result of the Election Procedural and Voting Committee chaired by Marianne Yewaisis and Ron Paluzzi. The group's goal was to update and revised the Election Procedures dated June 23, 2010 and revised August 29, 2013. Efforts were made to provide clarity to the election process and to ensure a fair and more efficient method of homeowner voting for the Village Trustees. The new Election Procedures was an insert to this Chatter. If you did not receive it, copies are available at the Administration Office. Discussion on this resolution will take place at the Open Trustees meeting on June 7th.

If after said discussion is heard and if the Board of Trustees passes this resolution, these Election Procedures will be dated as revised June 7, 2017 and will be enforce for the September 2017 Board of Trustees election.

Doing this definitely keeps the value of our homes up and people that are looking to buy here in our village really enjoy seeing the updated homes that are for sale and what their surrounding neighbors have done to their homes keeping the area beautiful. Keep up the good work!

EMPLOYEES & STAFF

Crestwood Village Six employees, office personal and custodial staff, in addition, to sub-contracting maintenance personnel have been chosen to work for our Crestwood Village Six Community. They are all professional in their work ethic, demeanor, and attitude. They know their jobs and perform them to the best of their abilities or to the restrictions that are placed on them by our governing documents. They are dedicated to Crestwood Village Six and are working towards bringing it to the status it should hold.

They deserve what is spelled out in our Rules and Regulations in Section 1 C that states: "Users of Village facilities are advised that courteous and civil behavior by Village residents and their guests is required at all times."

Every homeowner or resident should keep that in mind when speaking to the employees, staff and maintenance men. This should also apply to speaking to your neighbors or other residents also. It does no one any good if someone yells, curses, uses derogatory remarks when trying to communicate. No matter what the situation or problem, it can be spoken about in civil tones and they will work hard to bring a conclusion or response back to you as soon as possible.

Perhaps the most important thought is to respect others.

SIGNS & EXTERIOR HANGINGS

There is perhaps two areas of our village restrictions or regulations that is misunderstood and a reminder may be in order.

The Crestwood Village Six Declaration of Covenants & Restrictions in Article 5 Section 7 No Exterior Hangings, simply states the following:

“No cloths, sheets, blankets, laundry of any kind or any other articles shall be hung out or exposed on any part of the property, nor shall anything hung, painted or displayed on the outside of the windows or placed on outside wall or outside surfaces or displayed on doors of any buildings, nor shall any signs, awnings, canopies, or shutters be affixed or placed upon the exterior walls roofs or any part thereof, without prior written consent of the Community Association.”

The Crestwood Village Six Rules & Regulations Section 7.2 D; Home Maintenance states:

“No signs of any nature, except work permits, are permitted on the exterior of any building, dwelling unit or grounds. No sign or similar display in the interior of the home shall be visible from the exterior.” Note: (one) political sign has been approved for election but is restricted in size and in amount of time it may be displayed.

Signs are not allowed. That includes signs that a contractor may wish to place on your lawn during construction, installation of solar panels or even carpeting as examples. You as the homeowner are responsible to advise the contractor of the restriction and removing it.

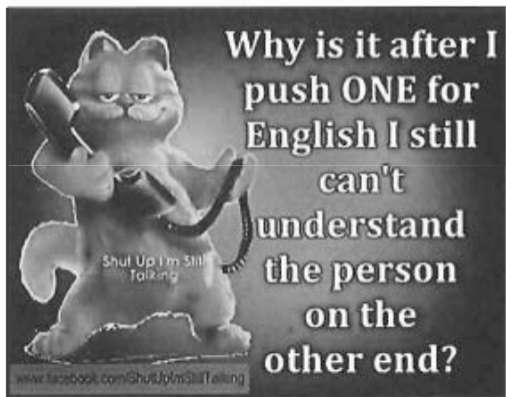
Food Pantry Truck

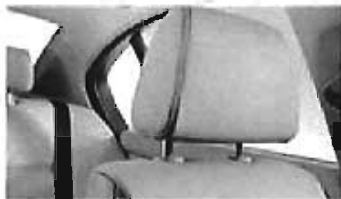

How to Mulch Around Trees: Spread Evenly!



It is ideal to apply a 2"-to-3" layer of mulch around a tree that extends out to its drip line. This layer of mulch does a few things including:

- Prevents weeds
-
- Retains moisture
- Maintains consistent soil temperatures
- Provides a nice buffer between equipment (mowers, weed wackers, etc.) and tree trunks
- Gives a finished look to the landscape

However, take care not to cover the base of the tree's trunk and its root flare with mulch. The sapling in this photo was not mulched properly. It was "volcano mulched," meaning the mulch was piled in a volcano shape right up to the bark of the trunk. If you pile mulch against the trunk, it will hold moisture there and may lead to root rot. It can also lead to the tree sending up secondary roots, which are weaker roots that will likely get zapped by the sun, frozen by frost, or strangle the tree. .

Instead, mulch your trees starting a few inches out from the trunk out to the drip line or beyond, as far as an 8-foot diameter. The root system of the tree extends far beyond its drip line. In a forest, that entire system benefits from naturally-occurring mulch.

Also, if you have old mulch around your trees, it may need to be raked to ensure it's not matted. Otherwise, if it's thick and matted water and air may not be able to seep through to the tree's root system. Mulch that's matted can also become weed-ridden.

Organic mulches usually need to be replenished a few times a year to ensure the right depth of mulch (roughly 3 inches) protects and nourishes your trees.

Waste Less, Save More!

You'll eat better *and* keep more money in your wallet, thanks to Joy's smart strategies.

The greens went brown before you could use them...again. Sound familiar? You're not alone; nearly 40% of food in the United States goes uneaten due to spoilage, bruises or blemishes, according to the Natural Resources Defense Council. In fact, the council found that the average American family of four loses up to \$2,275 annually due to food waste. Use these tips to stop food from going bad.

➤ MAKE A MOVE

Keep foods that spoil relatively fast, such as dairy products or soft fruit, in the front of your fridge or on the counter so you are more likely to grab them. If there are cans of unexpired soup in your cupboard that you know you won't use in time, donate them to a local food pantry.

➤ THINK OUTSIDE THE BOX

If a recipe calls for spinach but you have kale in the fridge, make the swap. You can also sub in pears for apples in a fruit crumble; leftover fish for chicken or beef in tacos; and fresh oregano for basil or thyme in a sauce. You get the idea—recipes are not set in stone!

➤ BE A GROCERY STORE REGULAR

It sounds counterintuitive to shop more often, but by making frequent trips to

the supermarket you can buy smaller quantities and prevent spoilage. If you don't want to add another errand to your to-do list, consider ordering online.

➤ MULTITASK YOUR INGREDIENTS

As you plan weekly meals, try to come up with several uses for produce and bulk items. For instance, you can enjoy bell peppers as a snack, stuffed with ground turkey or in an egg-white omelet.

➤ GIVE LEFTOVERS NEW LIFE

As tempting as it may be to dump leftovers on night two or three, challenge yourself to get creative. Use extra meatballs and sauce to make personal pizzas with veggies. Toss leftover rice and pasta into soup. Add veggie scraps when making chicken stock—or throw all your produce odds and ends together for a stir-fry.

THE RIGHT WAY TO STORE PRODUCE

REFRIGERATE

Apples, apricots, broccoli, plums, cucumbers, Brussels sprouts, cantaloupe, cauliflower and lettuce



LEAVE OUT ON THE COUNTER

Peaches, avocados, nectarines, bananas, watermelon (whole) and tomatoes



KEEP IN A COOL, DARK PLACE

Potatoes, onions and garlic. Stash separately in the kitchen cabinet or pantry so they don't absorb one another's odors.



Brown Recluse Spider

A brown recluse spider bite poisons the blood in a process called sepsis. Most spiders in the United States are not dangerous, but brown recluse spiders are the only ones in North America with amounts of venom that are considered medically significant.

Habits: These spiders are not aggressive and bite only when threatened, usually when pressed up against the victim's skin. They seek out dark, warm, dry environments such as attics, closets, porches, barns, basements, woodpiles, old tires and under siding. Its small, haphazard web, found mostly in corners and crevices, is not used to capture prey. Most bites occur in the summer months.

The brown recluse venom is extremely poisonous, even more potent than that of a rattlesnake. Yet recluse venom causes less disease than a rattlesnake bite because of the small quantities injected into its victims. The venom of the brown recluse is toxic to cells and tissues.

What are the symptoms of a brown recluse spider bite?

Brown recluse spider bites often go unnoticed initially because they are usually painless bites. Occasionally, some minor burning that feels like a bee sting is noticed at the time of the bite and a small white blister develops at the site of the bite. Symptoms usually develop two to eight hours after a bite. Keep in mind that most bites cause little tissue destruction. Be on the safe side and see a doctor.

Victims may experience these symptoms:

severe pain at bite site after about four hours,
severe itching,
nausea,
vomiting,
fever, and
myalgias (muscle pain).

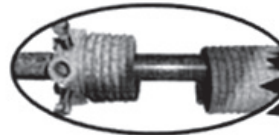

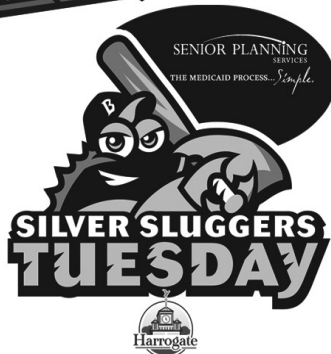
