The audit process is a time consuming endeavor that reviews our accounting practices and our total finances. Through the assistance of our auditor, and by our financial analyst Sal, our Treasurer Marianne, and our Administrator Val, the audit is a true reflection of the policies, dedication and professionalism of the Staff. The Board of Trustees could not be more pleased with knowing we are doing our very best to uphold our fiduciary responsibilities.

Although, it will only be a formality, the Secretary of the Board of Trustees will be requested to cast one vote for the four incumbent Trustees prior to them being sworn into office for their new two-year term. #### FOOD TRUCK

The **FOOD TRUCK** will be in the Deerfield parking lot at 10 AM on **October 10th**. Parking Lot opens at 8:30 a.m.

#### ANNUAL ROAD CLOSING

Safety Patrol will conduct our **Annual Road Closing** at the corner of Alpine & Congasia Roads on **Thursday**, **October 4**<sup>th</sup> from 8 a.m. until midnight.

#### LEAF & BRUSH PICKUP

Stanley Contracting will do a Leaf & Brush CURBSIDE pickup on Thurs., October 18th. DO NOT put items out until the day before or you will be fined \$10 per day. Only use paper recycle bags. Leaves and pine needles only in bags. No limbs or brush.

Manchester Twp. will also conduct a Leaf & Brush pickup on Thursday, October 25th.

#### HYDRANT FLUSHING

Manchester Twp. Utilities will be flushing hydrants throughout October and November. You may experience a difference in pressure and discoloration. Run your water tap only until it runs clear.

#### PRIORITY SNOW REMOVAL

In order to be added to the priority snow removal list you must have your doctor fill out and sign a Priority Medical Form and return it to the Administrative Office. To qualify you MUST require life sustaining medical care such as **Radiation**, **Chemotherapy**, **Dialysis** only. No other conditions qualify.

#### SPECIAL WARNING NOTICE

There have been several incidents that have raised serious concerns for the safety of our residents and the possibility of their homes being entered. In one of the instances, window screens had been raised in an apparent attempt to check to see if the windows had been left unlocked. In another the garage door was found open in the morning when it was closed the night before dark, the car had been left unlocked in the driveway and had a garage door opener in it.

A few years ago, we had similar instances in which access had been made into the homes and valuables taken. Fortunately, no one was injured at that time. As you may have seen on TV advertisements, homes are broken into all the time. Just because we live in an adult community does not mean it is safe from burglars or thieves. WE have to be aware of how we keep our home and property and be watchful of our surroundings and neighbors' property as well.

The main times the homes are entered is at evening time or when the house looks like the residents are gone for the evening or on vacation. Entry into homes that have unlocked windows, unlocked doors or open garage doors, no lights on, and no car in the driveway, or no sound coming from the inside of the home are the most likely targets for thieves.

Yes, you can get an alarm system installed, but they can be expensive.

Simple things you can do are the following:

- Keep a couple of lights on timers inside your home. Lights in homes act as a deterrent to thieves. Lights should go on at dusk and stay on past your bedtime.
- 2) Having a radio or television on is also a good idea when you are not at home.
- 3) Keeping doors and windows locked is the best thing you can do. If you are working in the rear of your home or property, make sure the front and side doors and windows are closed and locked. This includes the door from your garage into your home.
- 4) If you park your car outside, make sure you lock it at all times. Not only is your garage door opener in it, but many other things that a thief can take or use for identity theft.
- 5) The single most important light may be your outside light by your door. This should or could also be on a timer at very little cost. The use of an outside LED light bulb gives bright light at a very little cost compared to the safety it can provide or the deterrent factor it can have.
- 6) Call the POLICE if you see anyone suspicious or if someone is around your home that you do not know or that you had not invited. Also call the POLICE if you think someone has tried to gain entry into your home or garage.

#### FIREWISE INFORMATION FOR YOU AS A HOMEOWNER

The present FIREWISE Committee has done an excellent job of investigating, reporting, and creating a proposed plan of action and information to be disseminated to all residents. There is a flyer in this Chatter that was created by the firefighting service. It is presented to you as a homeowner for your consideration in your landscaping plans. It is not intended to make you drastically alter your property or to wipe out trees and plantings. It is a suggestion as to the considerations you may make as you move forward with work on you property. We as a community are to keep a country or park-like setting per our governing documents, that has always been a consideration and that is what makes our individual properties unique. However, there are considerations you may undertake that will keep your property landscaped but more fire resistant.

This FIREWISE program can help in making YOUR community safer, not only from forest fires, but also from other fire hazard. It may even have an effect on your insurance and that of the community's. As the FIREWISE Committee moves forward it will be reviewing the common wooded areas. In addition, they will be requesting other agencies that are responsible for large wooded areas surrounding our village to perform actions that will help protect our community. This request for the other agencies is to have "mowing or bush whacking" done to eliminate the ladder fuel. This request is the best alternative to controlled burns. A special community FIREWISE information day will be on Saturday December 1st at 11:00AM with lunch to be provided after the presentation.

#### NJ FOREST FIRE SERVICE CONTROLLED BURNING


This information is being given to you so that you can be informed and know what is going on. The NJ Forest Fire Service controlled burning season is from early October through March. They have been doing controlled burnings for many years and do it as safely as possible. They put out signage on the roadways where they will be doing controlled burns. The reason for the controlled burning is to remove the "ladder fuel", in other words, the dead growth of plants or other vegetation that would enable a forest fire to burn hotter and more intense, sending sparks into the air for great distances.

The controlled burn for this fall includes the Manchester Wildlife Management Area on the west side of our village borders. The controlled burn in this area has been done numerous times in the past. In the spring the wooded area known as the Crossley property at the end of Congasia Road will also have a controlled burn. As with "mowing or bush whacking" the native perennials like the ferns will return after a controlled burn, generally healthier.



#### WILDLAND HAZARD ASSESSMENTS

## Home Ignition Zones



Wisconsin Department of Natural Resources

ZONE 1

0-5 feet. Keep this area free from flammables. If landscaping is present, fire-resistant and high-moisture type plantings are preferable. Non-flammable mulches. Be mindful of decks, fences and keep flammable items off them if present.

ZONE 2

5-30 feet. Scattered vegetation, keep grasses mowed, space tree crowns about 10-20' apart, remove short vegetation from under larger trees (ladder fuels), as well as low hanging branches.

ZONE 3

30-100 feet. Clusters of trees should be kept separated (to avoid crown spread), wood piles and flammables such as fuel tanks and sheds should be kept in this zone or further out. Remove the "small stuff from underneath the big stuff".

ZONE 4

100+ feet. This zone should be thinned to a healthy level and managed for ecosystem health.

It is much easier to evacuate knowing that everything that could be done, was done





# BOARD OF TRUSTEES & FIREWISE COMMITTEE NEED INFORMATION


The Board of Trustees authorized a committee now known as the FIREWISE Committee to obtain information and to work with the residents and the association to first and foremost make our community safer from forest fires. This has been spoken about in Open Meetings and in the Deerfield Chatter.

The process of becoming a FIREWISE USA Community is a time consuming task creating a strategy for a safer community and creating a plan of action that could be implemented. It is to all our benefit for us to become a FIREWISE USA Recognized Community. Once recognized as a FIREWISE Community we can then also apply for grants that may total up to \$5,000.00 a year. Although the grant would not reimburse you as a resident, it would go to deferring your costs for the fire prevention plan for common property that the village owns.

The Board of Trustees and the FIREWISE Committee need information from you as a resident. The information needed is the total hours you and your family spent cleaning out your property under the trees or removing trees, shrubs, bushes, and even weeds this calendar year from January till now. If you had an outside company do work as mentioned above or tree removal, if possible a copy of the invoice would also be helpful. WE as residents, and the community association must show our commitment to not only becoming but also to continuing our commitment to being a FIREWISE USA Community. In other words committed to having a community that recognizes the need for preventative action to reduce the potential of forest fire or fire damage. The commitment dollar value we have to show is approximately \$28,000.00 this year that can be shown if you can supply the information you are asked for above. If you have the information please drop it off at the Administration Office.

A SPECIAL FIREWISE INFORMATION DAY will be held on Saturday ,DECEMBER 1st at 11:00AM with lunch to follow graciously supplied by the Crestwood Village Six Safety Patrol.

Your assistance in this project and your attendance at the information day is greatly appreciated.



#### Treasurer's Notes

Our auditor, Bob Elliott, presented his draft 2017-2018 report to the Board in September. He will be at the October 3<sup>rd</sup> Open meeting to discuss his official Audit Report that is included as an insert to this month's Chatter. It has been expanded to include a new Schedule of Other Operating Expenses – Other Expenses for more clarity.

As a result of this audit, the Board will be approving a resolution at the Open Meeting to clean up an old out of balance situation on the Village's Balance Sheet between the Operating Fund and the Replacement Fund. A copy of this interfund cash transfer resolution will also appear in this month's Chatter.

The August 31, 2018 Income/Expense Statement included in this month's Chatter is unaudited. Our financials continue to run on track with no surprises.

SRECs prices increased slightly in September to \$216.50 from \$211.00. We received a check for \$2,814.50 in September representing 13 SRECs produced in July. Let's hope for more sunny skies and mild weather this autumn. Enjoy the Halloween decorations that are beginning to appear in the Village and the changing leaf colors.

Remember October is Fire Prevention Month, time to change your smoke detectors' batteries or just buy new batteries and call the office to have maintenance men climb the ladder for you. This is a non-changeable service unless you do not provide the batteries. Newer smoke detectors use AA batteries. If your detectors are over 10 years old, please consider getting new smoke detectors. The Administration office can assist you.

#### WALKING WITH A FLASH LIGHT

It is highly recommended and good practice when walking during the evening hours to carry a flash light for visibility, while just exercising or walking your dog. However, the flash light should be facing down towards the roadway and your dog. Flashlights are not to be directed towards anyone's home, and especially not at the windows. That would not only be an invasion of privacy, but also it could create a sense of fear of an intruder in the neighborhood.

#### WALKING YOUR DOG

If you are walking your dog or cat at any time, you must have it on a fixed length (no greater than 6 feet long) leash. You must also pick up after your dog or cat and dispose of its droppings properly. No animal at any time is permitted to be outside of your home without a leash and proper disposal of their droppings is in your trash receptacle properly bagged, not in your neighbor's. Respect other people's property.

#### RIDING A BIKE

Riding a bicycle or even a tricycle is permitted in Crestwood Village Six. It is nice to see our residents go out for a ride for fun or exercise. Remember, if you do ride a bike, please keep to the right side of the road and ride with traffic, not into it. Wear clothes that make you more visible to the motorists and if riding at night you must have a light front and rear. It is a very good recommendation to carry identification with you in case of an accident or a health issue that may arise. Having telephone numbers of people to contact in case of an emergency is also highly recommended.

#### EMERGENCY CONTACT PHONE NUMBERS

You may know who to call in an emergency, but do your neighbors or more importantly the Crestwood Village Six Administrative Office know who to call if you are the one involved in an emergency situation? The emergency situation may involve your home, or you, or possibly a spouse or significant other. Having a current phone number of yourself and an emergency contact is very important and may be done by just calling the Administrative Office at 732-350-2656. Having current correct phone numbers can also assist our Advisory Board District Representatives and our Safety Patrol.

#### Resolution # 18 -

RESOLVED: The Board of Trustees of Crestwood Village Six Community Association resolve that as a result of the Fiscal Year 2017-2018 Audit an interfund cash transfer of \$41,897.71 is required from the Operating Fund to the Replacement Reserve Fund.

Explanation – This \$41,987.71 represents an old out of balance situation on the Village's Balance Sheet. Discussion on this resolution will take place at the Open Trustee's Meeting on October 3, 2018. For Fiscal Year 2017-2018, the balance in Account #1287 due from Operating Fund is \$41,987.71 and the balance in Account #1288 due to Replacement Fund is (\$41,987.71). Once approved, a check in the amount of \$41,987.71 will be drawn from the operating fund Ocean First checking account and deposited into the replacement reserve Edward Jones account.

Upon the advice of our auditor the Board of Trustees informally passed this resolution on September 12, 2018.

#### **RECIPE FOR SAFER COOKING**

Every year house fires cause millions of dollars in damage throughout the state and the country, as well as emotional and psychological stress. The house fires are mostly kitchen fires, and unfortunately many are in the homes of senior citizens.

Follow the tips below whenever you are thinking about cooking, be it a dinner meal, a hot lunch or just a quick cup of coffee or tea.

- 1) Never leave the kitchen if you have put something on the stove to cook. It is easy to get distracted and whatever is cooking can burn or start a fire. THIS IS #1 cause of house fires.
- 2) Wear short or tight-fitting sleeved clothing as loose clothing can easily catch fire.
- 3) Clean the cooking surfaces. There should not be any food or grease buildup on stoves or in ovens.
  - 4) Keep towels, pot holders, curtains, or any other flammable items away from the cooking surface.
  - 5) Turn pan handles inward, do not have them pointing out where you may accidently hit it and spill the contents.
- 6) If frying, do not over fill the pot as it will splatter and could cause a fire. If a fire does start, <u>immediately call the fire department</u> by dialing the emergency 911 number. Then the following:
  - 1) If a fire in a pot or pan does start, you might be able to stop a frying pan fire with baking soda. DO NOT ATTEMPT to put water or flour on a cooking fire. Slide a lid over the pot and turn the stove off. Leave the lid in place.
    - 2) If a fire starts in the oven, DO NOT OPEN the oven, shut the oven off and the fire will be smothered.

### Equipment to have:

- 1) Always keep a fire extinguisher close to the kitchen, Make sure it is the right type and you know how to use it.
- 2) Always perform a monthly test of all working smoke detectors.



- The proposed Complaint Resolution Procedure for Advisory Board Members was reviewed by both the Trustees present and the Advisory Board Members. This document will be reviewed by the entire BoT for possible adoption.
- Discussion ensued regarding dogs being walked on common property. A suggestion was made that signs be displayed on various common properties where this seems to be a continuing problem.
- RJ and Wayne both said there is no violation governing the bombing of insects by roof neighbors.

#### The Importance of Smoke Detectors

Smoke detectors are one of the most important safety devices you can install in your home. Once you've installed smoke detectors, it's absolutely vital to test them regularly to ensure that they will work during a fire. - Photoelectric units are better for smoldering fires—such as electrical fires in the walls—so they're ideal for kitchens and bathrooms where these fires tend to occur.
- Ionization units give the surrounding air an electrical charge and then measure whether the charge remains constant or if a fire consumes the oxygen in the air. These units are better suited to areas where fires get out of control, such as a basement or near a furnace.

Use this guide to ensure that your smoke detectors are working properly:

- Press the test button on the unit and wait for it to sound
- Light a candle and hold it six inches below the detector so the heated air will rise into the detector.
- If the alarm doesn't sound within 20 seconds, blow and the candle and let the smoke rise.
- If the alarm still doesn't sound, open the detector and clean the unit. Then, test the unit again.
- If the detector still isn't working, it should be replaced immediately.

#### Safety First

Replacing smoke detector batteries is critical to their usefulness. A great way to remember to change your smoke detectors' batteries is to do so twice a year during Daylight Saving Time. When you set your clocks forward or back an hour, also change your smoke detectors' batteries to keep your home and your family safe.
