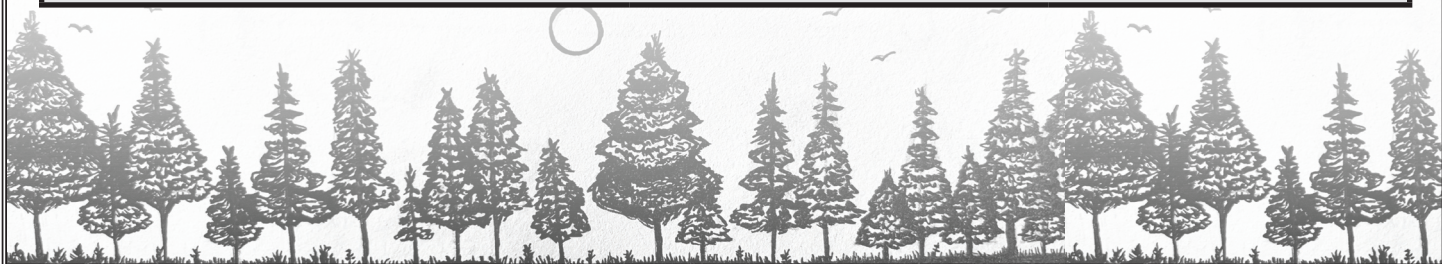

Treasurer Report

From Tom Perro

Spring is near!

The financial results reported in this chatter are for 7 months ending 1/31/24. Our Income for this period was \$1,230,496, which is \$20,105 better than expected. This continues to be the result of a greater number of new home owners moving in, higher closing fees, and more work order income. In addition, our expenses of \$960,579 were \$36,893 lower than budgeted. Operationally, we have a net Operating Income of \$269,917 which is \$56,998 higher than we expected. The Operating net income is what is used to fund our capital projects.

We have fought for, and won a lower insurance renewal with the help of our agent. This is a temporary reprieve from the escalating insurance costs we should expect next year.

One thing we can't avoid is change! Some of our residents moved here long ago when they were 55, and now they are not. As new 55-year-old people move into our community, the world is different, and they are bringing a new dynamic to our village. And here's some exciting news; a long-time resident is now the proud owner of an electric vehicle! I'm sure this will be the first of many and we are ready to embrace our changing environment. Let's be open-minded and welcome the changes that are inevitable, it should be fun!

TRUSTEE OPEN MEETING - FEBRUARY 7, 2024 AT 1 PM

ATTENDEES: Wayne Koester, President | Mike Thomas, 1st VP | Jean Balliet, Secretary (Absent) | Leo Ruscitto, 2nd VP | Phil Chidichimo, Trustee | Valerie O'Neill, Administrator | Tom Perro, Treasurer (Absent)

President, Wayne Koester opened the meeting at 1:05 PM followed by the salute to the flag and a moment of silence.

Administrator's Report was read by Valerie: Arrears paid 13-D Alpine \$11,462.73. 40-D Stonybrook Rd \$ 5670.00. 4 new Homeowners moved in. Chatter articles to be emailed to office until further notice. Admin Office closed President's Day 2-19-24.

Roll call was taken. In the absence of Jean, Valerie made a motion, seconded by Wayne to accept the minutes of Feb 21, 2024. Each present member voted and the minutes were accepted by all. There were no resolutions noted.

TRUSTEE REPORTS:

Leo: Home improvement requests are going well. Please get permission for all and any outdoor projects.

Mike: Welcome. January was a busy and challenging month for the BOT. We faced a large increase in our insurance renewals. We negotiated a 24% increase down to an 18% increase which is significant. We also are starting negotiation on the Stanley Contracting Maintenance renewal which is going to be a significant increase as well. We will negotiate over the next few months. The contract has many parts and the BOT doesn't have too many other options. These are challenging times, but we are relentless in our efforts to keep increases to a minimum.

The good news is we are moving forward with the painting project for the V-room next month. The painting will begin on 3/29/24 and end on approximately 4/6/24. Activities will be notified that the V-room will be closed for a week. In light of the above-mentioned increases, other projects have been put on hold for now. Any questions can be directed to me or to Val in the Admin. Office.

I've been in touch with Swift Paving regarding the east side roadwork and when it will start up again. It is April, weather permitting. The BOT is challenged each and every day. We are human. Mistakes are made.

We always have your best interest in mind. Happy Valentine's Day.

Phil: Firewise has 4 areas that need to be cleaned up: behind clubhouse, behind Medford, behind Ashley Rd, behind Berkshire Rd. Princeton Tree has given us estimates of \$2600.00 per day. Ash tree removal is also needed as well as grinding of stumps. Firewise will tag the trees needing removal.

Wayne: Many decisions are made daily by the BOT. All decisions effect the Board members as well as you. We don't always meet your expectations. I like living here. I like all of you. I don't get much love in return. We made a decision on snow a few weeks ago. Snowfalls are sometimes borderline. We salted roads. The salt kept the snow to a minimum. We salted them again. I drove around the village three times. Half the driveways were already shoveled. It was a failure on my behalf. I accept responsibility. I salted a third time. Driveways and sidewalks were not addressed. I've been here 17 years. Stay home. Don't go out. Don't risk injuring yourself.

Sometimes decisions are wrong. You can't plow blacktop. I could have done driveways. It would have cost as much as plowing roads. We shoveled for homeowners on Monday as best we could. I apologize. I made an error in judgment. I humble myself. It is what it is. Remember, to err is human. To forgive, divine.

CLUBS AND ACTIVITIES:

Julie Sutton of Safety Patrol announced that she's tired of requesting volunteers both at meetings and in the Chatter. States if she's tired, a lot of other people are tired, too. She offered a suggestion that we hold another Meet and Greet as we did before Covid. She would be willing to co-chair the event on a Saturday. Maybe clubs can help with some costs like food and mailing costs. People don't always read the Chatter. She again asked for volunteers.

Peggy Carucci of Bingo announced she also needs volunteers. They had a crowd of 144 people at this Sunday's Bingo. Bingo makes money. The Board needs money. It's fun! Volunteers need only give up one Sunday a month for 4 hours. Bingo will feed you!

Anna Serrano- Resident's Club - I do the advertisements for the Club. We also need volunteers. Our February Dance is a Prom to Remember on February 17th. Our March dance will have bag pipers. April Fools Rule Dance will be on April 20th. Signups are on Monday mornings and membership is \$10 a year.

Arlene Portenstein spoke about this week's upcoming movie, My Big Fat Greek Wedding 3, the cost of which is \$3. As of March, the Library will once again be accepting book donations. Come in for coupons.

Rosemary Weaver: Women's Club's February meeting will be a soup tasting, March will have the Lavender Lady, May will have hospice flowers. Bereavement group is Friday monthly. All are welcome. Refreshments are served.

PUBLIC PARTICIPATION:

Judy Noonan: Judy works for the Mayor's Office. Stated they received many phone calls regarding the snow removal from all villages. Asked if we have a list for wheelchairs and people on dialysis. Val explained only snow removal list we have is for those on Chemo, dialysis or radiation and only with a doctor's certification. The day and time of your treatments must be included and this year there are 5 people on that list.

Marianne Timoney 3-B Greenwood Lane: Suggested the BOT pass a Resolution to have dryer vents cleaned every other year. She also stated that the snow measurement for Manchester was 5.6 inches. She questioned whether we are reimbursed by Manchester for snow removal and lighting. Valerie answered yes.

Donna McGlashan 25-D Medford Rd: Snow was not cleared. An EMT spun out during storm. We must measure snow. Wayne came to her finger long after snow, talked to the Stanley snow removal guy and sent him away. We are always last. There are lots of aids in the area. If the aids fall, Village 6 is responsible. Complained that her finger was not re-paved.

Wayne stated her 3 minutes were up. He thanked her for her constructive criticism.

Loretta Lee 1 Amhurst Rd: Wants more speed for

telephone service. There's a new tower. Nothing's being done.

Judy Noonan 25-A Stonybrook Rd replied the Verizon is looking into another tower on 539 for 5G speed for internet only.

Loretta has 5G but it's no better than DSL. All her bills were unbundled and now costs her more.

Ana Serrano – 25-B Stonybrook Rd – Announced there is a program called Lifeline which offers discount internet and home phone. It is an income-based program. Government program. Try it.

Rosemary Weaver – 23 Berkshire Rd – Asked Wayne why the BOT hired Swift Paving to pave her side of the village. It was half-assed and lots of damage was done. It was poor quality compared to the west side. Quite inferior. The equipment used was inferior. Shabby. Not at all happy. And they took too long.

If tree stumps are supposed to be ground, why is there an ugly one across street from Wayne with a decoration on it? It's an eyesore.

A lot of people park their car in wrong direction. There is a Manchester ordinance which prohibits it. Safety Patrol used to tag those cars. Wayne stated that policy is no longer in existence. Cars hang out in the street when people have 3 vehicles in driveway. When are we going to have shutters painted on clubhouse? Mike stated it is on the list of things to do and will be addressed.

Marion Segarra 5 Kittery Ct – Stated that during snow storm Kittery Ct was a hot mess. It snowed more than 3 inches. Not plowing was unacceptable. Do we now pay for gutter cleaning? Wayne stated we clean for free twice yearly. Any cleanings after that are chargeable.

Agnes Arnold 2-B Alpine Rd – Thanked the BOT and all clubs and volunteers. It's not an easy job. She stated she saw the maintenance men out the day before the storm clearing storm drains. Good idea and thank you.

Barbara Gaddis 34-B Easton Dr – The mowers are constantly breaking her sprinkler heads and she's not home so she can't report it when it happens. Mike explained that if that happens on a regular basis, the heads are not installed properly. Machines are 3 inches high. Her heads are probably filled with sand and not lubricated. Therefore, not going down when they should. She needs to make sure they get cleaned and lubricated

yearly. Address it with her sprinkler company.

Joanne Rickard 43-B Mill Rd – Going forward, what is the plan for snow removal? Wayne responded he will make a better decision and stick with the protocol.

Lou Bruno 2 Ashley Rd – Wished to compliment all volunteers. They don't get enough credit. I love this village. People that complain about sprinkler heads, lubricate them and clean the sand out of them. Just go outside when you hear the mowers. I'm 87 years old. Stay home when it snows. I shoveled path to my mailbox. The swale was covered with ice. I fell on my ass and sat there in the cold for 20 minutes, wet and cold. The UPS guy passed and waved and kept going. Then he came back and another resident stopped and they helped me up.

Joseph Della 16-C Amesbury Rd – Complained about Swift Paving parking in his space for 8 days while paving roads and used his hose and didn't put it back. They went onto his grass. He stated he put in a stone extension to his driveway, without permission. He read an article regarding the U.S. Constitution coming back and stated he is protected by the Constitution, Bill of Rights, etc. He is granted life, liberty and the pursuit of happiness. He does not concede or agree to maritime laws. They are null and void. There's to be no trespassing on 16-C Amesbury Road.

Wayne responded that we all fall under the Constitution but in our Village we have all agreed to abide by the governing documents. He stated the BOT has indeed the right to go on any property in the Village.

Leo responded that the snow plows will ruin the stone addition to the driveway and that it is not even on this man's property. It must be removed or he will be fined accordingly.

Barbara Gaddis- 24-B Easton Dr – Inquired as to what the painted color markings were on her property. Wayne responded they are likely mark outs from utility companies. Val told her to call her in the office tomorrow and she can let her know what each color represents.

Laura Schlosser 47 Ashley Rd – Question for Phil and Firewise. Where are they going to clear behind Ashley Rd? Phil responded common ground.

She asked if Village 6 ever considered buying our own snow removal equipment and doing it ourselves. Valerie responded that we used to but there was a liability to the village so we got rid of all equipment for insurance

reasons. Mike explained that the snow removal contract this year has changed. We pay \$50,000 and the contractor works that off. Had we plowed the last storm, it would have been a cost of \$36,000. If we get a storm 8-12 inches the cost would be \$65,000 to plow. It is a per inch event now.

Donna McGlashan 25-D Medford Rd- Stated a long time ago we had a winter with a few blizzards and each homeowner was assessed \$100 per household. Carol Bonacci, 12 Ashley Rd, former treasurer of the Board, acknowledged this was 14 years ago. Wayne responded that the BOT tries NOT to assess homeowners.

Sue Ohman 2-A Ardsley Ave – She appreciated Wayne taking the blame for a bad call on snow removal. Asked why the contractor didn't just come in and start. It was explained that Wayne must make a call for the contractor to come in.

Wayne wished everyone a Happy Valentine's Day, Happy Easter and Passover. Our next meeting will be at 7 pm on April 10, 2024. The tax assessor will be in attendance.

The meeting was closed at 14:30 pm.

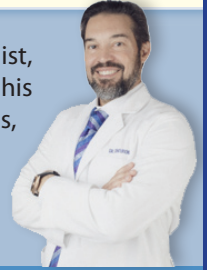

A Message from JGS Insurance

Dear Unit Owners:

We are pleased to advise you that Crestwood Village Six Community Association, Inc. has purchased insurance coverage through Jacobson, Goldfarb & Scott, Inc. At this time, we would like to give a brief overview of what coverages the Association has purchased, and what coverages should be purchased by the individual unit owners.

Insurance Provided by the Association through JGS Insurance

The Association's insurance policy provides property insurance on the buildings, on a blanket basis. Included in the definition of the buildings are the unit's fixtures, kitchen cabinets, interior walls, and carpeting as specified in the original building plans. The units are covered up to the standard builder's grade for anything installed by the builder, excluding upgrades or additions.

Coverage is written on a "Special Causes of Loss" basis with a replacement cost endorsement. Please be advised that the policy is subject to a \$10,000 deductible for covered losses that may be the responsibility of the unit owner.

Crestwood Village Six Community Association, Inc.'s insurance policy provides liability insurance for the association on all common areas. There is no coverage for the individual unit owner's liability under the Association's policy.

Insurance to be purchased by Unit Owners.

You should purchase a Condominium Unit Owners Policy (also known as a HO-6 policy). This policy will essentially cover your personal belongings; furniture, clothing, fine arts, jewelry, etc. Any items of particular value over \$2,000 should be appraised and scheduled onto your policy for the specified value. This coverage should be based on an all risk, "replacement cost basis". This would replace your contents, if totally or partially destroyed by a covered loss, with new items, of like kind and quality, without depreciation. This would be subject to whatever deductible you choose. Sewer back up coverage should be requested for your personal contents and belongings. The Association provides this coverage for damage to the buildings, but not the contents of the unit owners.

A building limit (or Coverage A under the HO-6 policy) of at least **\$10,000** should be purchased. Some of the units, either when originally purchased, or since that time, have added upgrades; better carpeting or padding, different kitchen cabinets, fireplaces, wood floor, upgraded painting, etc. The additional costs of these upgrades are your responsibility. These would be covered under the "Additions & Alterations" section of the HO-6 Policy for the additional cost of any upgrades in the unit. We also strongly recommend that the HO-32 endorsement, or similar endorsement, be added to the policy. This will broaden coverage for Additions and Alterations to Special Causes of Loss versus named perils. Unit Owners should also advise their personal insurance agent of the Association's property deductible, to ensure coverage is added to the appropriate section of their policy. Depending on the insurance carrier, these deductibles are typically covered either under the building limit, Coverage A, or as a loss assessment.

Also included in the HO-6 policy is personal liability of the Unit Owner(s). This covers the individual's personal liability arising out of the ownership of the unit, and we recommend a limit of at least \$500,000. Additional coverages that should be considered under your policy are; loss assessment, coverage for a liability assessment if levied onto the unit owners by the association. Extra expense and loss of use, if your unit becomes uninhabitable by a covered loss, your additional cost to relocate temporarily would be covered under your HO-6 policy. Coverages should be discussed with your personal Insurance Agent to tailor your coverages to your specific needs.

Unit owners that lease out their units should purchase a fire policy that would cover their unit's upgrades, any contents furnished in the unit, along with scheduling the personal liability arising out of the ownership of the unit onto your primary homeowner's policy. Additional coverages to be considered are loss of rents, if the unit becomes uninhabitable due to a covered loss, the loss of rents could be covered under this policy. Loss assessment is another important consideration.

The unit owner should require that the tenant's purchase a "Tenants Policy" (also known as a HO-4 policy). This would provide coverage on their personal belongings,

contents, personal liability, and loss of use. The unit owner should ask to be named as landlord on the tenant's policy.

This brief description does not contain, extend, modify or explain all the clauses, conditions, exclusions, or amounts of coverage under the policies. It only reflects basic coverage in force at the time of printing. Please refer to the individual policies on file with the Association for specific coverage.
